353 children (107 in 2012) have been served.

98 parents (36 in 2012) have recorded a Legacy Video to share with their children. Sadly, 53 parents have passed away since our first event in August 2008.

6 High School Seniors living with a terminally ill parent (2 in 2012) received \$1,000 Inheritance of Hope Legacy Scholarships.

Inheritance of Hope hosted 3 Legacy Retreats® in 2012, two in Orlando and one in NYC at no cost to participating families. All events serve children with a terminally ill parent by creating memories, building a community of support, and providing tools to help their parents leave a legacy. Orlando features a day at Walt Disney World's Magic Kingdom, a day at Universal Studios, and a day at Sea World. NYC features a Circle Line cruise around Manhattan, Radio City Christmas Spectacular, and Rockefeller Center's Top of the Rock.

Kristen died on October 26, 2012, but not without being incredibly intentional about her legacy and not without starting Inheritance of Hope to help other families like ours be intentional about their legacies.

Kristen would be thrilled that you are supporting the families Inheritance of Hope serves. She was passionate about helping them in a way that no one else does. She also saw Inheritance of Hope as an important piece of her legacy.

Seeing the direct impact of Inheritance of Hope on me and my children in the wake of losing Kristen these past six months has been very affirming. I can clearly see the importance of the work we're doing on a daily basis. Being intentional with the time she had was therapeutic for Kristen. Having videos, gifts, and other things Kristen left has been a blessing for me to share with our children. Those things are a great comfort to the children, as well. Our youngest listens to a recording of Kristen singing and reading most nights and feels close to her.

Other children around the country who've lost a parent have similar, irreplaceable blessings from their parent because Inheritance of Hope changed the response to their situation.






2012 Expenses
