It is so comforting to be with people who get it.

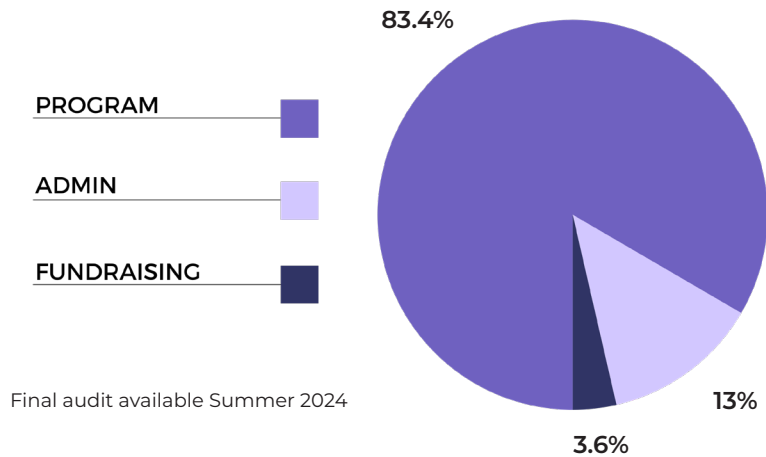

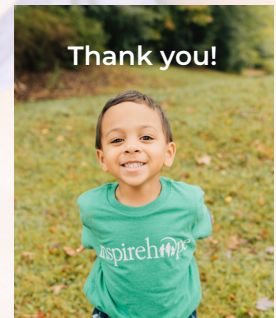
