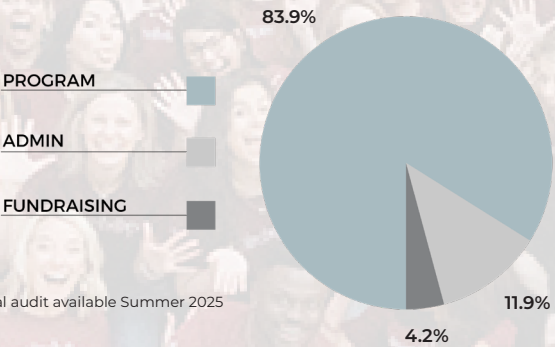
THANK YOU MONTHLY DONORS
